Basis of bearing was transferred from a GPS survey of Franklin County monuments FRANK 134 and FRANK 35, and is based on State Plane Coordinate System NAD 83 (1986), Ohio South Zone, and determined the centerline of right-of-way of Harrisburg Pike as being N 55°09'38" E.
