

**TEMPORARY CONSTRUCTION EASEMENT  
PARCEL 27-T  
0.0253 ACRE TRACT (1100.1 S.F.)  
EXHIBIT "A"**

Situate in the City of Columbus, County of Franklin, State of Ohio, Virginia Military Survey No. 971, being part of Lot No. 16, Block No. 4 of Wilshire Heights Subdivision as recorded in Plat Book 15, Page 32 and conveyed to Columbus Home Solutions, LLC by deed recorded in Instrument No. 201503130031825 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

Commencing for reference at the southwest corner of said Lot No. 16, being at the intersection of the north right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the east right of way line of Racine Avenue (50' public right of way);

thence along the south line of said Lot No. 16 and the north right of way line of said Mound Street, South eighty-one degrees forty-five minutes fifty-nine seconds East (S81°45'59"E) for ten and 00/100 feet (10.00') to the **TRUE POINT OF BEGINNING** of the herein described tract of land;

thence leaving said lines across said Lot No. 16, North thirty-six degrees forty-five minutes fifty-nine seconds West (N36°45'59"W) for fourteen and 14/100 feet (14.14') to the west line of said Lot No. 16 and the east right of way line of said Racine Avenue;

thence continuing across said Lot No. 16, South eighty-one degrees forty-five minutes fifty-nine seconds East (S81°45'59"E) for one hundred fifteen and 1/100 feet (115.01') to the east line of said Lot No. 16 and the west right of way line of the 1st Alley West of Warren Avenue (16' public right of way);

thence along said lines, South eight degrees fourteen minutes one second West (S08°14'01"W) for ten and 00/100 feet (10.00') to the southeast corner of said Lot No. 16, being the intersection of the north right of way line of said Mound Street with the west right of way line of said Alley;

thence along the south line of said Lot No. 16 and the north right of way line of said Mound Street, North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for one hundred five and 1/100 feet (105.01') to the **TRUE POINT OF BEGINNING**, containing 0.0253 acres (1100.1 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street stretching west to east from Binns Boulevard to Ogden Avenue, having a bearing of S81°45'59"E, is designated the "Basis of Bearing" for this description.

This description was prepared under the direction of Cody Schneider, Ohio Registered Surveyor No. 8670, of Woolpert Inc., and is based on a field survey performed during February and March, 2013, as well as February, 2016.
