Situated in the State of Ohio, County of Franklin, City of Columbus located in Quarter Township 1, Township 1, Range 19 (USML) and being a part of a 0.436 acre tract of land conveyed to Olympic Properties, LLC by deed of record in I.N. 200905110067036 of the Recorders office, Franklin County, Ohio and being more particularly described as follows:

Beginning at a point, said point being 40.00 feet right of station 59+47.92, said point being the point of beginning;

Thence N 03°38'56" E a distance of 100.01 feet to a point, said point being 40.00 feet right of station 60+47.93;

Thence S 87°39'13" E a distance of 20.00 feet to a point, said point being 60.00 feet right of station 60+48.38;

Thence S 03°38'56" W a distance of 48.38 feet to a point, said point being 60.00 feet right of station 60+00.00;

Thence N 86°21'01" W a distance of 5.00 feet to a point, said point being 55.00 feet right of station 60+00.00;

Thence S 03°38'56" W a distance of 51.74 feet to a point, said point being 55.00 feet right of station 59+48.26;

Thence N 87°39'13" W a distance of 15.00 feet to the point of beginning.

The above described area is contained with the Franklin County Auditor's Parcel Number 010-013993, within said boundary is 0.040 acres, more or less.

This description and survey was prepared and reviewed on August 3, 2015, by Joseph S. Bolzenius.

The centerline described in this document refers to the centerline of construction as shown on the City of Columbus roadway plan “Kenny Road Sidewalk Improvements (3113 Dr. E)”.

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConelsville CORS stations were used, which establishes a bearing along the centerline of Kenny Road to be N 3°17'54"E between Henderson Road and station 86+01.50 (just south of Weybridge Road).
