This memorandum is a recommendation for construction contractor selection and processing the construction legislation for the 2010 Guardrail and Fence Repair Contract.

Project Scope: The Department of Public Service is responsible for maintaining the City's roadway system in a safe manner. A guardrail and fence repair contract is needed to restore accident-damaged guardrail and fence, replace deteriorating structures and install new structures. This contract addresses guardrail and fence needs throughout the entire City of Columbus network.

Fiscal Impact: This contract will be funded from 2010 operating funds.

Schedule: This project was bid on January 25, 2010. The contract length is 365 days from the date of the Notice to Proceed. The Notice to Proceed date is estimated to be March 22, 2010.

Recommendation:

With reference to bids received on January 25, 2010, I wish to make the following recommendation for the subject improvement:

Award is made to the lowest responsive and responsible and best bidder, M.P. Dory Company, for their bid of \$330,585.00 which is \$19,415.00 under the Engineer's estimate of \$350,000.00.

It is also recommended that the contract for said project be in the amount of \$350,000.00 with the difference between the bid amount and \$350,000.00 be added to the force account.

Please note that the Lake Erie's original bid is fundamentally equivalent (i.e. within 10% of the low bid after credit) to M.P. Dory's bid.

Please respond to this e-mail indicating approval of the recommended contractor and establishing the contract amount at \$350,000.00 – M.P. Dory Construction – or approval of Lake Erie Construction. If you approve Lake Erie Construction, please provide an explanation.

Note:

M.P. Dory has one "willful" or "serious" OSHA violation in the last three years: one worker failed to wear required fall protection.

Emergency Action:

Emergency action is necessary to allow for timely execution of this contract and construction to protect the safety and welfare of the public.
