Our box dimensions are 3.74 x 1.57 x 5.91 inches and normally fit the standard coils in Harm Reduction vending machines. I'm happy to send you a sample, but I understand that, due to the nature of the bid, it may not be appropriate. Our product has the same FDA-approved formulation as Narcan® along with a 48-month expiration.
