Thence South 04° 29' 48" West a distance of 351.83 feet along centerline of Courtright Road (R/W width varies) to a point at centerline Station 38+10.38;

Thence North 85° 28' 51" West a distance of 30.00 feet leaving the centerline across Courtright Road to an iron pin set on the westerly right-of-way line of Courtright Road and the southerly line of a 0.980 acre tract conveyed to Community Housing Intent, Inc. by deed of record in Instrument Number 202207070099754 and the northerly line of the Grantor's 1.020 acre tract, 30.00 feet left of centerline station 38+10.39 and being the **TRUE POINT OF BEGINNING** for the Temporary Easement herein described;

Thence South 04° 29' 48" West a distance of 63.02 feet along the westerly right-of-way of Courtright Road, 30.00 feet left of the centerline station 37+47.36;

Thence leaving the westerly right-of-way line of Courtright Road on the following six (6) courses across the Grantor's 1.020 acre tract;

- 1. North 85° 30' 06" West a distance of 6.00 feet to a point 36.00 feet left of centerline station 37+47.36;
- 2. North 04° 29' 54" East a distance of 20.53 feet to a point 36.00 feet left of centerline station 37+67.89;
- 3. North 85° 30' 06" West a distance of 2.00 feet to a point 38.00 feet left of centerline station 37+67.89;
- 4. North 04° 29' 54" East a distance of 12.00 feet to a point 38.00 feet left of centerline station 37+79.89;
- 5. South 85° 30' 06" East a distance of 2.00 feet to a point 36.00 feet left of centerline station 37+79.89;

Thence South 85° 28' 51" East a distance of 6.00 feet continuing along the line common to the Grantor and the 0.980 acre tract to the **TRUE POINT OF BEGINNING**, containing 0.009 acres, more or less, being subject to all easements, restrictions, and right-of-way of record.
