

MEMORANDUM OF UNDERST ANDING with City of Columbus and Columbus Board of Education

City agrees to complete the following:

- Convey title to the properties known as 1316-1336 Summit Street, 010-038861, and 1298 Summit Street, 010-047199 for a joint tability between the Columbus Board of Education and The Ohio State University.
- Transfer title to the lots known as 1298 Summit Street and 1316-1338 Summit St. when payment is received for \$2,035 (\$2,000 for property, \$35 for recording fees), made payable to the Treasurer, City of Columbus.
- * The City of Columbus will vacate the alley adjacent to the School property (between Seventh Avenue (north), and the southern terminus at the existing park, once the Board of Education has taken title to all of the properties that abut the west side of the alley.

Columbus Board of Education agrees to:

- Purchase the property known as 1316-1336 Summit Street, 010-038861, and 1298 Summit Street, 010-047199 for a joint facility between the Columbus Loard of Education and The Ohio State University.
- Apply for all qualified tax exempt one or keep property tax: is current.
