

**DESCRIPTION OF A 0.007 ACRE PARCEL  
PARCEL 3-T**

Situate in the State of Ohio, Franklin County, City of Columbus, Part of Lot No. 7 of Nathaniel Merion's Subdivision recorded in Plat Book 1, Page 189, T5N, R22W, Half Section 38, Section 26, Refugee Lands, and being part of a 140 foot by 140 foot parcel conveyed to J 3 M & E, LLC. recorded in Instrument Number 200508290177188 in the Franklin County Recorder's office and being more particularly described as follows:

Being a parcel lying on the right side of centerline of Fairwood Avenue.

**Commencing** at an iron pin set at the intersection of Frebis Avenue at centerline station 10+04.36 and Fairwood Avenue at centerline station 18+28.87 (reference the west line of Half Section 38 and the east line of Half Section 39 being South 86 Degrees 11 Minutes 27 Seconds East 8.73 feet);

Thence South 03 Degrees 16 Minutes 21 Seconds West 274.54 feet along the centerline of Fairwood Avenue (50' right of way) to a point at centerline station 15+54.33;

Thence South 86 Degrees 43 Minutes 39 Seconds East 35.00 feet perpendicular to the centerline of Fairwood Avenue to a point on the grantors north line and the south line of a 0.265 acre parcel conveyed to J 3 M & E, LLC. recorded in Instrument Number 200508290177188 at 35.00 feet right of centerline station 15+54.33, said point being the **Point of Beginning** for the parcel herein described;

Thence from the **Point of Beginning** South 86 Degrees 43 Minutes 39 Seconds East 9.00 feet along the grantors north line and the south line of said 0.265 acre parcel to a point at 44.00 feet right of centerline station 15+54.33;

Thence across the grantor the following three courses:

1. South 03 Degrees 16 Minutes 21 Seconds West 35.05 feet to a point at 44.00 feet right of centerline station 15+19.28;
2. North 86 Degrees 43 Minutes 39 Seconds West 9.00 feet to a point at 35.00 feet right of centerline station 15+19.28;
3. North 03 Degrees 16 Minutes 21 Seconds East 35.05 feet to the **Point of Beginning**.

The above described contains 0.007 acres more or less including the present road which occupies 0.000 acres and is contained in Auditors Parcel Number 010-115121-00 which presently shows 0.450 acres.

Subject to all legal easements and rights of way.

All iron pins set are 3/4 inch diameter x 30 inch long rebar with a cap stamped "Canter S-7226".

All stations and offsets are referenced to the centerline of right of way of Fairwood Avenue.

Grantor claims title by Instrument Number 200508290177188 in the Franklin County Recorder's office.
