[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Section 4, Township 2, Range 18 of the United States Military Lands and being 0.0930 acres (4050 square feet) out of a 0.4770 acre tract conveyed to Beedle Oil Company as described in Deed Book 2389, Page 498 and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for the PED Safety Improvement Sinclair Road project in plan 3658-E for the City of Columbus, and being located entirely within the existing right of way and the following described points in the boundary thereof:

Commencing at a mag spike in the intersection of the existing centerline of Sinclair Road (fka: Bronson Road and Indianola Avenue) as established in Plat Book 40, page 29 Station 40+00.66, and the existing centerline of Strimple Avenue as described in Deed Book 2187, Page 125 Station 1+00;

Thence along the said centerline of Sinclair Road bearing **South 03 degrees 22 minutes 36 seconds West**, a distance of **25.00** feet to a point, being the southwest corner of said City of Columbus property, also being the northwest corner of said Beedle Oil Company centerline Station 39+75.66 and being the **Point of Beginning**.

Beginning at a point on the centerline of right of way of Sinclair Road at station 39+75.66;

Thence leaving the said centerline of Sinclair Road along the north property line of said Beedle Oil Company property and said south line of the said City of Columbus property, **South 86**

degrees 35 minutes 38 seconds East, a distance of **30.00** feet, to the northwest corner of a parcel of land owned by City of Columbus as described in Official Record 25371 B02 and also being 30.00 feet right of Sinclair Road Station 38+40.64;

Thence parallel to the centerline of Sinclair Road bearing **South 03 degrees 22 minutes 36 seconds West** a distance of **135.00** feet and being the west line of said City of Columbus property to an iron pin set being 30.00 feet right of Sinclair Road Station 38+40.64;

Thence along the north property line of a 3.7316 acre tract of land described to YDT Sinclair Road, LLC tract II in Instrument Number 199803310074841, and the south property line of said City of Columbus property bearing **North 86 degrees 35 minutes 38 seconds West** a distance of **30.00** feet to a point being on the centerline of right of way Sinclair Road Station 38+40.66;

Thence along the centerline of right of way of Sinclair Road bearing **North 03 degrees 22 minutes 36 seconds East** a distance of **135.00** feet to the **Point of Beginning**.

The above-described parcel contains 0.0930 acres (4050 square feet) more or less, all of which is within the right of way of Sinclair Road and formerly part of parcel 010-104777.

Subject to all legal rights-of-way and/or easements, if any, of previous record.

Grantor claims title by Deed Book 2389, Page 498 in the Franklin County Recorder's Office.

This description was prepared and reviewed on September 12, 2022 by Christopher M. Cook, Registered Surveyor #8424.

All iron pins set are 5/8" reinforcing bars, 30" long with a cap stamped "Dynotec Inc".

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (2011) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Sinclair Road in this area North 03 degrees 22 minutes 36 seconds East.

This description is based upon a field survey performed by Dynotec, Inc. in the years 2018-2022.

The stations referred to herein are from the centerline of construction of Sinclair Road as found on plan 3531-E on file in drawer E with the City of Columbus, Franklin County, State of Ohio.
