BEGINNING at the southwest corner of said Lot No. 16, being at the intersection of the north right of way line of Mound Street (50' public right of way, originally dedicated as Dartmoor Road, see City of Columbus Ordinance No. 196-43) with the east right of way line of Binns Boulevard (50' public right of way);

thence along the west line of said Lot No. 16 and the east line of said Binns Boulevard, North twelve degrees fifty minutes one second East (N12°50'01"E) for twenty-four and 79/100 feet (24.79');

thence leaving said lines across said Lot No. 16 for the following four (4) courses:

- 1. South seventy-seven degrees nine minutes fifty-nine seconds East (S77°09'59"E) for five and 00/100 feet (5.00');
- 2. South twelve degrees fifty minutes one second West (S12°50'01"W) for fifteen and 61/100 feet (15.61');
- 3. South eighty-one degrees forty-five minutes fifty-nine seconds East (S81°45'59"E) for twenty-six and 66/100 feet (26.66');
- 4. South eight degrees fourteen minutes one second West (\$08°14'01"W) for eight and 75/100 feet (8.75') to the south line of said Lot No. 16 and the north right of way line of said Mound Street;

thence along the south line of said Lot No. 16 and the north right of way line of said Mound Street, North eighty-one degrees forty-five minutes fifty-nine seconds West (N81°45'59"W) for thirty-two and 38/100 feet (32.38') to the **POINT OF BEGINNING**, containing 0.0083 acres (359.5 S.F.), more or less, subject however to all covenants, conditions, restrictions, reservations and easements contained in any instrument of record pertaining to the above described tract of land.

Bearings are based upon the Ohio State Plane Coordinate System, South Zone, NAD83 (2007). Said bearings originated from said coordinate system by GPS observations and observations of Franklin County Survey Monuments 5/14 and COC 1-83. The portion of the centerline of Mound Street, Street stretching west to east from Binns Boulevard to Ogden Street, having a bearing of S81°45′59″E, is designated the "Basis of Bearing" for this description.
