Situated in the State of Ohio, County of Franklin, City of Columbus located in Quarter Township 1, Township 1, Range 19 (USML) and being a part of a 6.069 acre (calculated) tract of land conveyed to The Cunard Village Condominium by deed of record in OR 53 F01 (CPB 7 PG 77) of the Recorders office, Franklin County, Ohio and being more particularly described as follows:

Beginning at a point, said point being 35.00 feet right of station 29+05.71, said point being the point of beginning;

Thence N 02°55'27" E a distance of 402.60 feet to a point, said point being 35.00 feet right of station 33+26.31;

Thence S 87°04'33" E a distance of 2.00 feet to a point, said point being 37.00 feet right of station 33+26.31;

Thence N 02°55'27" E a distance of 56.31 feet to a point, said point being 37.00 feet right of station 33+26.31;

Thence S 87°03'43" E a distance of 8.00 feet to a point, said point being 45.00 feet right of station 33+26.31;

Thence S 02°55'27" W a distance of 25.00 feet to a point, said point being 45.00 feet right of station 32+45.00;

Thence S 87°04'33" E a distance of 8.00 feet to a point, said point being 37.00 feet right of station 32+70.00;

Thence S 02°55'27" W a distance of 339.29 feet to a point, said point being 45.00 feet right of station 29+05.71;

Thence N 87°00'28" W a distance of 2.00 feet to the point of beginning.

The above described area is contained with the Franklin County Auditor's Parcel Number 010-185543. Within said boundary is 0.024 acres, more or less.

The centerline described in this document refers to the centerline of construction as shown on the City of Columbus roadway plan "Dierker Road Sidewalk Improvements (3112 Dr. E)".

The basis of bearings in this description area based on the State Plane Coordinate System, Ohio South Zone, NAD83 (NSRS 2011), which were determined by GPS observations conducted by the Patrick Engineering survey staff. The Columbus, Mount Vernon and McConnelsville CORS stations were used, which establishes a bearing along the centerline of Dierker Road to be N 2°55'27"E between Henderson Road and Bethel Road.
