In collaboration with the Centers for Disease Control and Prevention (CDC), the National Association of County and City Health Officials (NACCHO) is pleased to inform you that your Health Department has been selected as a 2023 Building Up Infection Prevention & Control in Local Departments in Healthcare-Associated Infections and Antimicrobial Resistance (BUILD HAIAR) Project awardee with the conditions listed below. This HAI/AR demonstration site project seeks to strengthen the local health department (LHD) capacity for healthcare-associated infections (HAIs) and antimicrobial resistant (AR) prevention and response for the BUILD HAIAR project.     - If the registration submitted during the application period expires in the next 60 days, then a new registration must be submitted.
- Documentation of an approved indirect and fringe rate. If you do not have an approved rate, please provide a signed statement that captures the breakdown of the proposed rate(s) (i.e., breakdown of burden rate, 10% de minimis indirect cost rate, etc.).
  - If the documentation was submitted during the application process, it does not have to be submitted again.

**If you wish to move forward in a contract with NACCHO for this initiative under the above conditions, please reply to this email by Monday, October 9, 2023.**

If you are unable to accept the award, please let us know immediately. The HAI/AR project team that will be supporting you includes NACCHO and CDC.
