This project was for the installation of 1775 ft. of 12-inch waterline in Holt Road. The City of Columbus agreed to participate in (110) percent of the difference in the cost of materials only between an 8-inch and the 12-inch waterline mentioned above. The City of Columbus is requesting authorization to pay this difference to South-Western City Schools.

The Planning Area is “Westland” and includes the west side of Holt Road between Alkire Road and Big Run South Road.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

There is no timeline as this is a request for reimbursement from the developer, per the City Code 1105.15.

7. **A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

The water line was constructed to serve a new South-Western City school.

8. An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.

Columbus City Code 1105.15 (C), states “All water main extensions in the city shall be paid for by the applicant or developer requesting such extension. Where a water main extension is required by the city to be installed larger than eight (8) inches in nominal diameter, the city shall pay one hundred ten (110) percent of the difference in the cost of the pipe, fittings and valves between the installation of an eight (8) inch water main and the water main installed.

The Estimated Material Cost is indicated below:

- A. 12” waterline and appurtenances - \$69,298.98
- B. 8” waterline and appurtenances - \$49,535.15

Difference in the cost (A minus B) - \$19,763.83

Plus 10% (Per Code Sec.1105.15C1) - \$1,976.38

Total Estimated Amount to be paid by the City to the Developer - \$21,740.21
