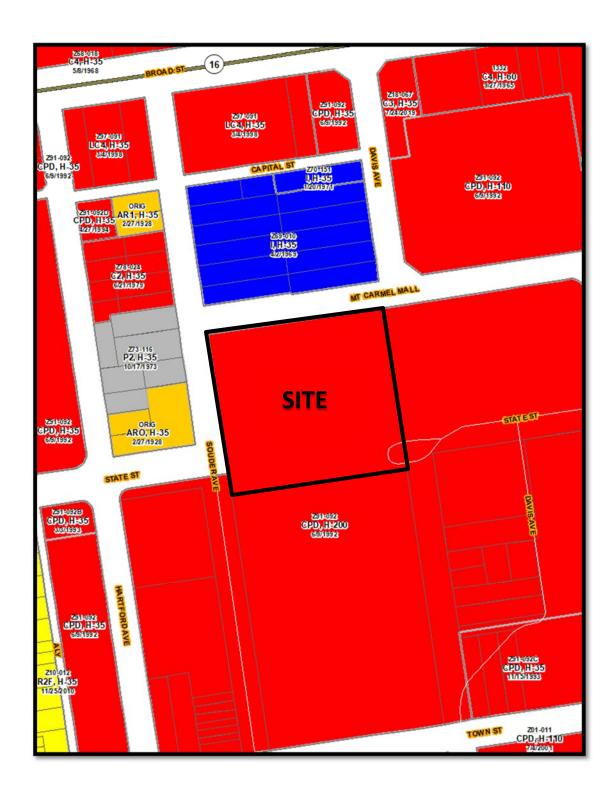

BACKGROUND:

- The 2.0± acre site consists of part of one parcel formerly developed with the Mount Carmel West Hospital in the CPD, Commercial Planned Development District. The applicant requests the AR-3, Apartment Residential District to permit a multi-unit residential development.
- North of the site is a medical office building in the I, Institutional District. South and east
 of the site is the former Mount Carmel West Hospital campus in the CPD, Commercial
 Planned Development District. West of the site is an educational facility in the AR-O,
 Apartment Office District.
- Concurrent CV20-069 has been filed and includes variances to vision clearance, landscaping, building lines, and rear yard. Additionally, a variance to provide all required parking off-site is included. That request will be heard by City Council and will not be considered at this Development Commission meeting.
- The site is within the planning boundaries of the West Franklinton Plan (2014), which recommends regional mixed-use land uses at this location. Additionally this site is within an area that has adoption of the new Columbus Citywide Planning Policies (C2P2) Design Guidelines.
- The site is located within the boundaries of the Franklinton Area Commission, whose recommendation is for approval.

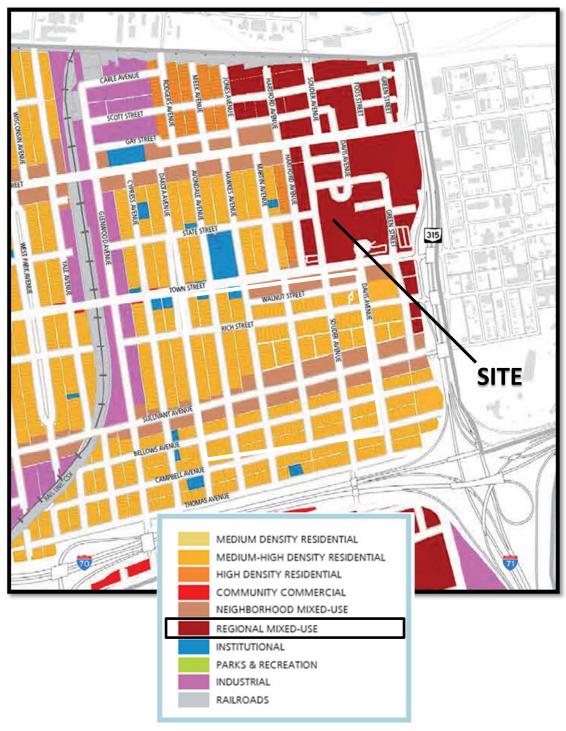
CITY DEPARTMENTS' RECOMMENDATION: Approval.

The proposed AR-3, Apartment Residential District will permit the site to be developed with a multi-unit residential development. The proposed zoning district and allowable density is comparable to the *West Franklinton Plan's* land use recommendations for mixed-use land uses at this location. Additionally, the proposed land use is consistent with residential infill developments in urban neighborhoods.

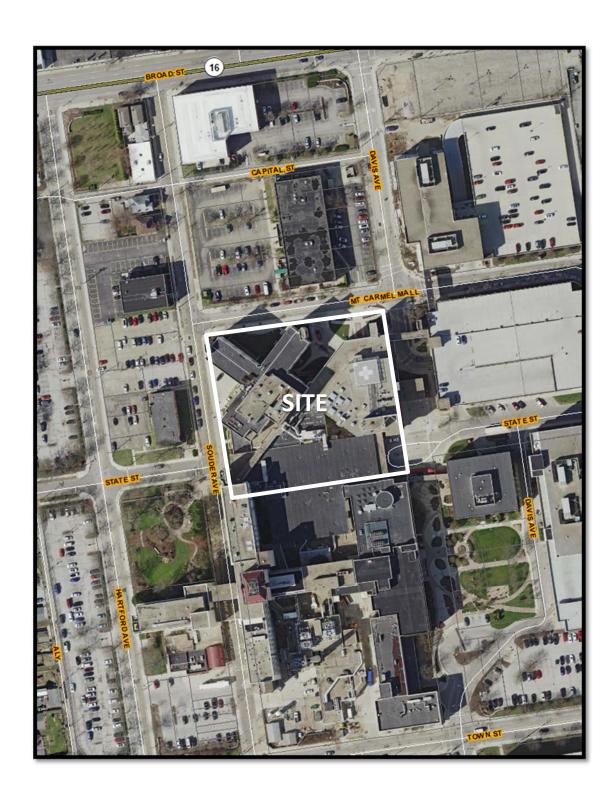


Z20-063 793 W. State St. Approximately 1.88 acres CPD to AR-3
