The work under this contract consists of Janitorial Services for various Department of Public Utilities Facilities. The work to be performed under these specifications will be Janitorial Services at the Southerly Wastewater Treatment Plant, Jackson Pike Wastewater Treatment Plant, Compost Facility and the Sewer Maintenance Operations Center. Other Department sites may be added in the future. The work to be performed under these specifications will include cleaning services for not only office areas but also other industrial type areas such as store rooms, stock rooms, construction trailers, areas adjacent to garages, kitchens and break rooms. The Contractor shall furnish any and all cleaners, disinfectants, waxes, wax stripping materials, wastebasket liners, toilet seat liners, sanitation pad liners and any other products required to provide the cleaning services.

The performance of this project's activities to provide Janitorial Services for various Department of Public Utilities Facilities will provide orderly, properly maintained buildings for the use of the staff and public. This will prevent these facilities from deteriorating and requiring replacement that can produce an impact to the budget. No community outreach or environmental factors are considered for this project.

This is the first renewal.

Anticipated renewal. The original contract allows for three (3) extension periods on a year to year basis. This modification is to provide the funding necessary for the payment of services to be provided through April 2022.

The same exact service is required as originally bid. No lower pricing/more attractive terms and conditions are anticipated at this time.

This contract will be funded incrementally with modifications on approximately an annual basis. Three contract renewals are anticipated at this time for DOSD Facilities. If other DPU Facilities are added, if unforeseen issues or difficulties are encountered that would require additional funding, a modification would be requested. The expected cost for this project is as follows:
