[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 15 of Flavel Tuller's Survey of Quarter Township 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 1 of the Barbary Ridge Subdivision as recorded in Plat Book 84, Page 52, as conveyed to Denise Sharif by deed of record in Instrument Number 201304020053712 and Instrument Number 201105160062475, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the left side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at a southwest corner of said Lot 1, being 40.00 feet left of Hard Road centerline station 147+18.98;

Thence North 02 degrees 20 minutes 22 seconds East, a distance of 10.00 feet along the westerly line of said Lot 1 to a point being 50.00 feet left of Hard Road centerline station 147+18.98;

Thence South 87 degrees 38 minutes 42 seconds East, a distance of 86.02 feet across said Lot 1 to a point being 50.00 feet left of Hard Road centerline station 148+05.00;

Thence North 61 degrees 23 minutes 29 seconds East, a distance of 29.16 feet across said Lot 1 to a point being 65.00 feet left of Hard Road centerline station 148+30.00;

Thence North 02 degrees 21 minutes 18 seconds East, a distance of 51.00 feet across said Lot 1 to a point in the northerly line of said Lot 1, being 116.00 feet left of Hard Road centerline station 148+30.00;

Thence South 87 degrees 38 minutes 42 seconds East, a distance of 16.13 feet along the northerly line of said Lot 1 to the northeast corner of said Lot 1, being 116.00 feet left of Hard Road centerline station 148+46.13;

Thence South 02 degrees 21 minutes 18 seconds West, a distance of 46.00 feet along the existing westerly Right-of-Way line of Tripoli Court, and along the easterly line of said Lot 1 to an iron pin set being 70.00 feet left of Hard Road centerline station 148+46.13;

Thence along the arc of a curve to the right for 47.12 feet across said Lot 1, and along the proposed northerly Right-of-Way line of Hard Road, having a radius of 30.00 feet, a central angle of 90 degrees 00 minutes 00 seconds, a chord bearing of South 47 degrees 21 minutes 18 seconds West, a chord distance of 42.43 feet to an iron pin set at the intersection with the existing westerly Right-of-Way line of Tripoli Court, being 40.00 feet left of Hard Road centerline station 148+16.13;

Thence North 87 degrees 38 minutes 42 seconds West, a distance of 97.15 feet along the southerly line of said Lot 1, and along the existing northerly right-of-way line of Hard Road, to the **Point of Beginning**, containing 0.054 acres, more or less;

Of the above described area, 0.054 acres is contained within the Franklin County Auditor's Parcel 610-235360.

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.

This description was based upon an actual field survey of Hard Road by Stantec Consulting Services, Inc., in October and November of 2010, under the direction of Tim A. Baker, Registered Surveyor Number 7818.
