Commencing at a point in the southerly right-of-way line of Main Street (80'), as originally created by a Congressional Record recorded May 15, 1820, as platted in Bexley Highlands, Plat Book 14 Page 15, said point being 40.00 feet right of centerline station 869+80.80;

Thence along the southerly right-of-way line of Main Street, South 87 degrees 50 minutes 28 seconds East, a total distance of 389.32 feet to a point, being 40.00 feet right of centerline station 873+70.00 East Main Street, and being the **TRUE POINT OF BEGINNING** of the parcel herein intended to be described;

Thence along the southerly line of East Main Street, South 87 degrees 50 minutes 28 seconds East, 40.00 feet to a point, said point being 40.00 feet right of centerline station 874+10.00 East Main Street;

Thence across part of said Grantor tract the following three (3) courses:

Bearings are based on English Ground Coordinates converted from the Ohio State Plane Coordinate System, South Zone, NAD83 (86 Adj.). Control for bearings come from Franklin County Survey Control Network Monuments "Frank44" to "Yearling", having a bearing of North 23 degrees 38 minutes 38 seconds East.

The stationing referenced herein is based on the State of Ohio-Department of Transportation's state route sections on continuous mileage stationing where S. Drexel Avenue intersects with Main Street, being Straight Line Mileage (SLM) 16.84 and Station 889+15.20.

All iron pins set are 5/8" rebar, 30" in length with a yellow plastic cap with "EP FERRIS SURVEYOR 8230" inscribed on top. This description is based on a field survey by E.P.
