3. Thence along said north line, S 46° 12' 17" W for a distance of 93.36 feet to a 5/8 inch rebar with cap "GPD" set;

N 19° 16' 09" W for a distance of 162.13 feet to the True Place of Beginning and containing 0.2789 acres (12,151 sq.ft.) of land, more or less, of which 0.0590 acres of land are contained within the present road right of way and subject to all easements, restrictions and covenants of record as surveyed by Steven L. Mullaney, P.S. Number 7900, for Glaus, Pyle, Schomer, Burns & DeHaven, Inc., dba GPD Group, in February of 2013.
