**BEGINNING** at a point at the southwest corner of the Grantor, the southwest corner of the said Lot 42, the southeast corner of Lot 41 of the said Highway Park, the southeast corner of that tract conveyed to JLP Investments, LLC by the instrument filed as Instrument Number 201205100066237, and on the existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way line of Hudson Street station 81+28.05, said point being the **TRUE POINT OF BEGINNING** of the parcel herein described;

Thence along the westerly line of the Grantor, the westerly line of the said Lot 42, the easterly line of the said Lot 41, and the easterly line of the said JLP Investments, LLC tract, **North 03 degrees 29 minutes 26 seconds East for a distance of 19.37 feet** to a point being 49.37 feet left of the centerline of right-of-way of Hudson Street station 81+27.94;

Thence crossing through the lands of the Grantor, the following four (4) courses:

- 1. **South 27 degrees 21 minutes 07 seconds East for a distance of 8.61 feet** to a point being 42.00 feet left of the centerline of right-of-way of Hudson Street station 81+32.40;

Ferebee tract, **South 03 degrees 29 minutes 28 seconds West for a distance of 22.00 feet** to a point at the southeast corner of the Grantor, the southeast corner of the said Lot 42, the southwest corner of the said Lot 43, the southwest corner of the said Frederick D. Ferebee tract, and on the said existing northerly right-of-way line of Hudson Street, said point being 30.00 feet left of the centerline of right-of-way of Hudson Street station 81+68.44;

Thence along the Grantor's southerly line, the southerly line of the said Lot 42, and the said existing northerly right-of-way line of Hudson Street, North 86 degrees 11 minutes 03 seconds West for a distance of 40.39 feet to the TRUE POINT OF BEGINNING of the parcel herein described.

The above description contains a total area of **0.013 acres** (**0.000 acres** are located within the Present Road Occupied resulting in a net take of **0.013 acres**), all of which are located within Franklin County Auditor's **Parcel Number 010-061290.**

The bearing for this description are based on Grid North as referenced to South 86 degrees 18 minutes 11 seconds East for the centerline of right-of-way of Hudson Street east of Interstate Route 71 (FRA-1-25.33) as referenced to the Ohio State Plane coordinate system (South Zone) and the North American Datum of 1983, as established utilizing a GPS survey and NGS OPUS solution.

The stations referenced herein are from the plans known as Hudson Street on file with City of Columbus, Ohio having "E" plan number 3575.
