Sir,

The following investigation was conducted concerning the City of Columbus' 2022 annual objection to **91335120649** issued to **UDF Limited Partnership II**, which is doing business as **United Dairy Farmers 649** located at **530 S. Hague Avenue, Columbus, Ohio 43204**. The Division of Liquor Control does not list an individual owner of this permit.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created **seventy-seven (77)** official police reports concerning incidents at the listed liquor establishment between **January 2021** and **November 2022**. These reports referenced robberies, menacing, drug offenses, overdoses, intoxicated persons needing assistance, sexual assault, persons with outstanding warrants, domestic violence, assault, and motor vehicle theft, including:



In addition, the Columbus Division of Police and Division of Fire have been dispatched to **530 S. Hague Avenue, Columbus, Ohio 43204** on **three hundred eighty-one (381)** calls for service, **one hundred ninety-seven (197)** in 2021, and **one hundred eighty-four (184)** in 2022 at **UDF**. These calls for service include responses to a shooting, robberies, persons with a gun, persons with a knife, indecent exposure, sex crime, OVIs, overdoses, narcotics complaints, intoxicated persons needing assistance, assaults, fights, fires, domestic violence, disturbances, persons with outstanding warrants, and motor vehicle thefts. CFD specifically responded to **nine (9)** overdoses in 2022.
