[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, located in Farm Lot 17 of Flavel Tuller's Survey of Section 1, Township 2 North, Range 19 West, United States Military Lands, as recorded in Plat Book 3, Page 60, and being a part of Lot 63 of the Foxboro Village Section 2 Subdivision as recorded in Plat Book 51, Page 106, as conveyed to Thomas L. Millican by deed of record in Deed Book 3768, Page 419, all records of the Recorder's Office, Franklin County, Ohio, and being more particularly described as follows:

Being a parcel of land located on the right side of the Plat of the Centerline of Right-of-Way of FRA-C.R. 61-1.10, as recorded in Plat Book____, Page____;

Beginning at the northwest corner of said Lot 63, being 40.00 feet right of Hard Road centerline station 135+26.34;

Thence South 87 degrees 39 minutes 05 seconds East, a distance of 28.00 feet along the northerly line of said Lot 63, and along the existing southerly right-of-way line of Hard Road, to the northeast corner of said Lot 63, being 40.00 feet right of station 135+54.34;

Thence South 30 degrees 14 minutes 11 seconds East, a distance of 5.93 feet along the easterly line of said Lot 63 to a point being 45.00 feet right of station 135+57.54;

Thence North 87 degrees 39 minutes 05 seconds West, a distance of 31.20 feet across said Lot 63 to a point in the westerly line of said Lot 63, being 45.00 feet right of station 135+26.64;

Thence North 02 degrees 20 minutes 55 seconds East, a distance of 5.00 feet along the westerly line of said Lot 63, to the **Point of Beginning**, containing 0.003 acres, more or less;

Of the above described area, 0.003 acres is contained within the Franklin County Auditor's Parcel 590-173280.

The bearing datum of the afore-described parcel is based upon the Ohio State Plane Coordinate System, South Zone, NAD 1983 (1986 Adjustment), as measured using G.P.S. methods through the Franklin County Engineer's stations FRANK 74, FRANK 174, FCGS 7772, FCGS 6651, FCGS 2232, and FRANK 2218 RESET.

This description was based upon an actual field survey of Hard Road by Stantec Consulting Services, Inc., in October and November of 2010, under the direction of Tim A. Baker, Registered Surveyor Number 7818.
