

MASTER SOFTWARE LICENSE AGREEMENT ONE-TIME LICENSE RIDER

Rider to the Master Software License Agreement dated June 29, 2012 (the "MSLA") between <u>City of Columbus</u> ("Licensee"), AND INFORMATION BUILDERS, INC., ("IBI" or "Licensor"), a New York corporation with principal offices at 2 Penn Plaza, New York, NY 10121-2898.

IBI hereby grants to the Licensee a non-exclusive license to use the Operating System Version of the items listed below (the "Software"), on the computer and at the location specified in accordance with the terms and conditions of the MSLA. Some Windows / Intel, UNIX or Linux based servers have a multicore chip set. A multicore server has one or more chips each containing multiple processors, referred to as "Cores". If the authorized Computer Model is a Windows / Intel, UNIX or Linux server which is virtualized, then the Computer Model listed herein is deemed a "Virtual Server" and the Licensee must identify the subset number of "Active Cores" which the virtualization technology limits the Virtual Server to. The Active Cores for a Virtual Server must be on the same physical machine and shall not be segmented across multiple physical machines. Licensee understands that upgrade fees will apply if the permitted number of Active Cores on a Virtual Server is exceeded. Licensee understands that upgrade fees will apply if a non-virtualized Computer is replaced with a Computer with more physical Cores than the original Computer. However, the Licensee shall have the option to convert a non-virtualized Computer to a Virtual Server at any time upon entering into a new Rider setting forth the number of Active Cores; in such case upgrade fees will apply only if the number of Active Cores for the Virtual Server exceeds the total number of Cores for the originally licensed Computer.

This Education Package is a prepaid spending account that can be used for training at IBI or customer locations, for mentoring or personal training, or for attending the annual Summit conference. The Education Package Fee is due upon execution. The Education Package must be used within 12 months and charges are based on the IBI Training Curriculum in effect at the time the training takes place. The parties will coordinate and pre-approve appropriate expenses in the event any Instructor travel and living expenses are to be incurred. These costs and any shipping costs for materials are not included in the Education Package Fee.

Special Terms:

• In addition to the amounts above, upon execution Licensee shall be invoiced an additional prorated amount of \$29,810.57 to coterminate the InfoResponse through June 30, 2014 for the Software previously licensed on Master Software License Agreement One-Time License Rider dated June 29, 2012 and Master Software License Agreement One-Time License Rider dated July 31, 2012 for Agreement Nos. 633C.01 and 633C.02.
