Study of existing sewer infrastructure including CCTV. Prepare engineering master plan report outlining recommended improvements for the entire Franklinton East and part of Franklinton West areas. Produce detailed design drawings for half of the Franklinton East area to include sewer rehabilitation or replacement as needed, inflow & infiltration removal, green infrastructure and drainage improvements as needed (via contract mod). Prepare detailed design drawings for the Scioto Peninsula area on an if-authorized basis.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

Project will produce a master infrastructure study by November 2013. Detailed design services will be performed in 2013 and 2014 via a planned contract modification.

Project will address consent order obligations to the Ohio EPA in the Dodge Park CSO area. Project will also facilitate redevelopment of Columbus' oldest neighborhood, Franklinton. The tremendous economic and social benefits to the area have been previously estimated and presented in a report "East Franklinton Creative Community District Plan".

This contract for producing the infrastructure report will be \$2,042,434.54. The anticipated contract modifications which will provide detailed design services for utility and roadway improvements are estimated at \$3,000,000.
