Work performed will be mostly in the North Linden planning area and one site in the Near East planning area. Work will include construction of the mitigation of street and yard flooding, and reduce roadside drainage problems at eight defined locations within or near the Linden Neighborhood of the City of Columbus. Areas include Emerald Avenue, Framingham Circle, Ganson Drive, Walmar Drive, Northridge Road, and Medina Avenue.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

**\*For construction contracts:**

Contract work is required to be completed in a manner acceptable to the City within 365 days from the date that a Notice To Proceed (NTP) is given by the City.

**7. A narrative discussing the economic impact or economic advantages of the project; community outreach or input in the development of the project; and any environmental factors or advantages of the project.**

Work will include construction of the mitigation of street and yard flooding, and reduce roadside drainage problems at eight defined locations within or near the Linden Neighborhood of the City of Columbus. Areas include Emerald Avenue, Framingham Circle, Ganson Drive, Walmar Drive, Northridge Road, and Medina Avenue. This project will benefit the public by improving safety and property damage concerns.

**8. An estimate of the full cost of the Contract including a separate estimate of any and all phases or proposed future contract modifications.**

The bid amount and proposed award amount is \$2,628,930.66, including a 20% construction contingency amount that will be utilized to fund needed and approved changes in the work. No contract modifications are anticipated at this time; however, construction exigency might later compel modification of this contract, if unforeseen difficulties are encountered.
