[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.045 acres within a 1.047 acre parcel conveyed to TRIBES LLC, as described in Instrument Number 201001040000643 and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning on the easterly proposed right-of-way of Hamilton Road, said point being 60.00 feet right of centerline Station 111+99.24;

Thence along the said easterly existing right-of-way of Hamilton Road, North 3°07'54" East a distance of 190.01 feet to the northwesterly corner of the said 1.047 acre tract and being 60.00 feet right of centerline Station 113+89.25;

Thence along the northerly line of the said 1.047 acre tract, South 86°52'05" East a distance of 10.00 feet to a point being 70.00 feet right of centerline Station 113+89.25;

Thence across the said 1.047 acre tract, South 3°07'54" West a distance of 184.08 feet to a point being 70.00 feet right of centerline Station 112+05.17;

Thence across the said 1.047 acre tract, South 86°52'06" East a distance of 11.00 feet to a point being 81.00 feet right of centerline Station 112+05.17;

Thence across the said 1.047 acre tract, South 3°07'54" West a distance of 5.93 feet to the southerly line of the said 1.047 acre tract and being 81.00 feet right of centerline Station 111+99.24;

Thence along the said southerly line, North 86°52'05" West a distance of 21.00 feet to the point of beginning, containing 0.045 acres, more or less.

The above described area is within Auditors Permanent Parcel Number 010-288032.

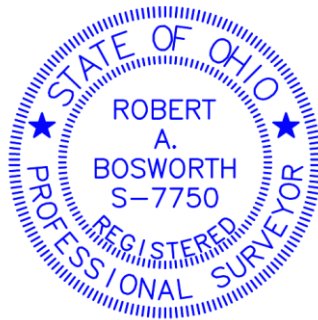

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (96 CORS) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Hamilton Road as North 3°07'54" East.

The stations referred to herein are from centerline right-of-way of Hamilton Road as found on O.D.O.T. right-of-way plan Hamilton Road.
