This award established a "blanket" type of service contract to augment existing engineering personnel within the Water Supply Group, Division of Power and Water on an as-authorized, as needed basis. Tasks initiated or completed to date include the following.

- 1. The design and engineering services during construction of 2 new low service pumps for DRWP (LSPs-1 & 6).
- 2. The design renovation for Technical Support Offices was completed on May 2, 2007.
- 3. HCWP Collector Arm Replacement Welding and Coating Inspections were completed for Basin 1 and Basin 2.
