[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, Township of Plain, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.053 acres within a 1.013 acre parcel conveyed to THE KROGER CO., an Ohio corporation as described in Instrument Number 201602240021801 and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning on the easterly existing right-of-way of Hamilton Road and the southwesterly corner of the said 1.013 acre tract, said point being 60.00 feet right of centerline Station 103+44.42;

Thence along the said easterly existing right-of-way of Hamilton Road, North 3°19'21" East, a distance of 144.44 feet to the northwesterly property corner of the said 1.013 acre tract and being 60.00 feet right of centerline Station 104+88.85;

Thence along the northerly line of the said 1.013 acre tract, South 86°56'39" East a distance of 13.00 feet to a point being 73.00 feet right of centerline Station 104+88.91;

Thence across the said 1.013 acre tract, South 3°19'21" West a distance of 108.91 feet to a point being 73.00 feet right of centerline Station 103+80.00;

Thence across the said 3.551 acre tract, South 31°54'14" East a distance of 43.34 feet to a point on the southerly property line of the said 3.551 acre tract and being 98.00 feet right of centerline Station 103+44.59;

Thence along the said southerly line, North 86°56'37" West a distance of 38.00 feet to the point of beginning, containing 0.053 acres, more or less.

The above described area is within Auditors Permanent Parcel Number 010-295573.

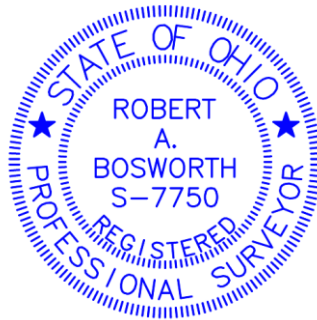
This description was prepared and reviewed on October 6, 2016 by Robert A. Bosworth, Registered Surveyor #7750.

Grantor claims title by Instrument Number 201602240021801 in the Franklin County Recorder's Office.

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (96 CORS) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Hamilton Road as North 3°19'21" East.

The stations referred to herein are from centerline right-of-way of Hamilton Road as found on O.D.O.T. right-of-way plan Hamilton Road.
