As you know, the University Area Review Board (UARB) is charged with protecting the architectural character and promoting good design solutions for commercial and residential properties in the Impact District as outlined in the University Area Planning Overlay (C.C. 3372.500). The UARB meets once a month to review proposed alterations to buildings, sites and structures under its jurisdiction and to make decisions on the appropriateness of each proposal.

The UARB is comprised of representatives from several different constituencies; three from the American Institute of Architects (AIA), one from the Area Commission (UAC), one from the Business Association (UCBA), one from the Apartment Association (CAA) and one At-Large. All board members are appointed by the Mayor for three-year terms and serve without compensation.

The term of Mr. Bill Graver, representing the CAA, expired January 31, 2013. Mr. Graver has served admirably as a member of the UARB since 2007 and is a great asset to the Board. He has been reaffirmed as a recommended candidate by the Columbus Apartment Association, as per code.

In the attached letter and supporting material, real estate developer and property manager Bill Graver, has indicated he wishes to seek reappointment to the UARB. The Planning Division recommends the reappointment of Mr. Graver to the UARB. His new term would expire January 31, 2016.
