Situate in Half Section 41, Township 5N, Range 22W, in the City of Columbus, County of Franklin, State of Ohio, and being part of a 0.075 acre tract of land, part of Lot 192 of the Estate of Wm. Merion Plat Book 17, page 256 conveyed to Warren Mitchell Davidson by deed recorded in Instrument No. 201909110117367 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

BEGINNING at the southeast corner of said 0.075 acre tract, said point being the intersection of the north right of way line of Moler Street (50' public right of way) with the west right of way line of 17th Street (50' public right of way), 25.00 feet left of centerline Station 109+40.04;

thence along the south line of said 0.075 acre tract and the north right of way line of said Moler Street, North eighty-six degrees twenty-one minutes thirty-two seconds West (N86°21'32"W), for seventeen and 24/100 feet (17.24') to a point 42.24 feet left of centerline Station 109+40.07;

thence leaving said lines across said 0.075 acre tract, North three degrees thirty-eight minutes twenty-eight seconds East (N03°38'28"E), for five and 87/100 feet (5.87') to a point 42.23 feet left of centerline Station 109+45.94;

The above described area contains 0.002 acres (101.43 sq. ft.), more or less, of which the present road occupies 0.000 acres, more or less, which is part of the Franklin County Auditor's Permanent Parcel Number 010-033208.

The stations and offsets of the above description are measured from the proposed centerline of construction for 17th Street.

The bearings shown hereon are based on the centerline of Ann Street from Frebis Avenue to Whittier Street as being North 03° 44' 35" East, from an adjusted field survey using multiple VRS observations and/or direct GNSS measurements from Franklin County monuments FRANK 43, 973, and Continually Operating Reference Station (CORS) COLB, based on the Ohio State Plane Coordinate System, South Zone, and North American Datum of 1983 (NSRS 2007) scaled to ground by 1.0000488019 about the projection false northing and easting (0, 1968500).
