This modification increases the funding for the purchase of wholesale electric power and associated services, including annual membership fees and participation in journeyman lineworker safety and training programs.

The Division of Power (DOP) had an active journeyman lineworker training program with another vendor, who, until AMP's program, was the sole company offering this training locally. The need purchase of wholesale electricity and ancillary services was anticipated to have modifications.

Only two programs offer the lineworker training locally and AMP's program cost per attendee is the lowest cost option. Additionally, American Municipal Power, Inc. is a non-profit organization for state municipalities and, acting as a broker, has contracted for competitive prices on the City's behalf through a bidding process.
