Commencing at a 1-inch iron pin set in a monument box set at the centerline intersection of Hamilton Avenue (70 foot right of way) and Martin Luther King Jr. Blvd (80 foot right of way);

Thence **North 08 degrees 03 minutes and 58 seconds West** along the centerline of said Hamilton Avenue a distance of **65.57** feet to a point in said line, said point being 65.57 feet left from Martin Luther King Jr. Blvd centerline station 100+00.10;

Thence North 81 degrees 56 minutes 02 seconds East, leaving the said centerline, a distance of **35.00** feet to the existing easterly right of way line for Hamilton Avenue, same being also the west line of the grantor's 0.209 acre tract (Lot 1) and at the beginning of a curve, being 65.52 feet left from Martin Luther King Jr. Blvd centerline station 100+35.10;

Thence **South 87 degrees 55 minutes 27 seconds East** a distance of **41.72 feet** across said Lot 1 to a point in the existing northerly right of way line for Martin Luther King Jr. Blvd, same being the southerly line of the grantor's 0.209 acres tract (Lot 1) and being a point on a curve, said point being 40.00 feet left from Martin Luther King Jr. Blvd centerline station 100+87.73;

Thence on the arc of a curve to the right and non-tangent to the previous course, with the existing northerly right of way line for Martin Luther King Jr Blvd and the south line of said Lot 1 having as its elements a delta of 04 degrees 54 minutes 59 seconds, a radius of 230.01 feet, an arc length of 19.74 feet with a **Chord Bearing of South 75 degrees 28 minutes 07 seconds West with a Chord length of 19.73 feet** to a point of compound curvature, being 40.00 feet left from Martin Luther King Jr. Blvd centerline station 100+64.56;
