E, and being more particularly described as follows:

All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning FOR REFERENCE at Franklin County Geodetic Survey (FCGS) Monument Number 1462 at the intersection of the centerline of Lockbourne Road with the centerline of Marion Road (from the west) and located at station 41+88.82; thence North 03°54'25" East, along the centerline of Lockbourne Road, a distance of 3127.66 feet to a Mag Nail set at the southwesterly corner of said 40-foot wide strip (D.B. 2546, PG. 277) and at the northwesterly corner of that 0.655-acre tract as described in a deed to D.I.Y. Car Wash Systems, Inc., of record in Official Record Volume 9059, Page H01 and located at station 73+16.48, the TRUE PLACE **OF BEGINNING:**

Iron pins set consist of a 5/8" rebar, 30" long capped with a plastic cap stamped "CITY OF COLUMBUS RIGHT-OF-WAY MARKER".
