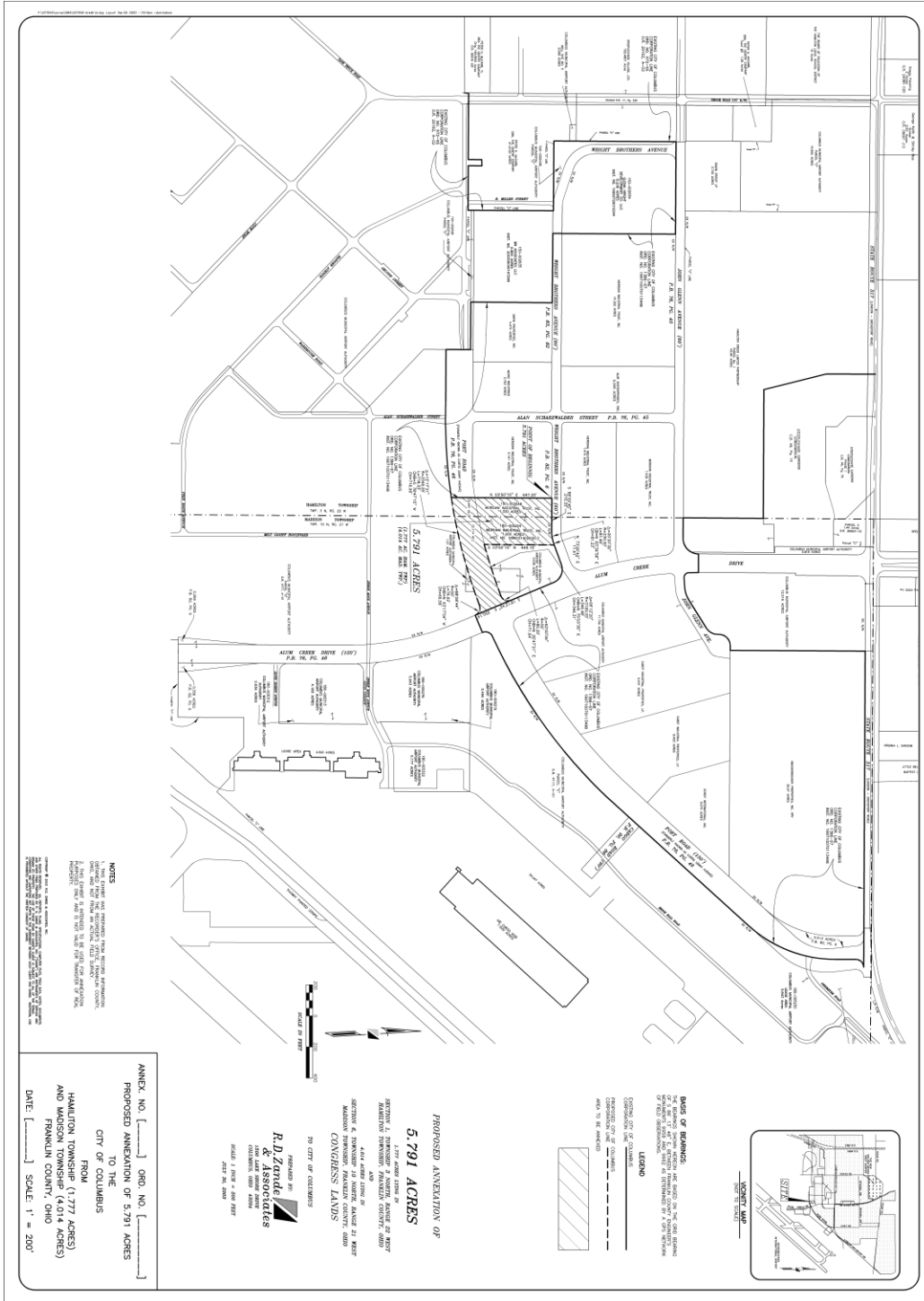


MAP ANNEXATION AN03-032 5.791 Acres in Hamilton & Madison Townships Meridian Industrial Trust
