

**23-WD**  
**DESCRIPTION OF 0.006 ACRES**  
**Proposed Right of Way**  
**Masjid As-Sahaba**  
**2533-2543 Cleveland Ave**

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 4, Township 1 North, Range 18 West, United States Military Lands and being part of Lot 711, Lot 712 and Lot 713 as the same is numbered and delineated upon the recorded plat Simons Neil and Simons Linden Addition in Plat Book 5, Page 354 and described in a deed to Masjid As-Sahaba by deed of reference in Instrument No. 200805130073694. All references to records herein are those located in the Recorder's Office of Franklin County, Ohio and being more particularly described as follows:

Commencing at the intersection of the north right of way line for Genessee Avenue (75' width) with the westerly right of way for Cleveland Avenue (70' width), said point also being in the southeast corner of Lot 715 of said Simons Neil and Simons Linden Addition; same being the northwest corner of said Lot 5 of

Thence **N 03 degrees 46 minutes 19 seconds E** a distance **131.18 feet** with the westerly right of way line for Cleveland Avenue to an iron pin set, said iron pin being in the east line of the grantor's tract and the ***TRUE POINT OF BEGINNING***;

Thence **N 86 degrees 08 minutes 10 seconds W** a distance **8.00 feet** across the grantor's tract to an iron pin set, said iron pin being 8.00 feet west of the westerly right of way line for Cleveland Avenue as measured by right angles;

Thence **N 03 degrees 46 minutes 19 seconds E** a distance **34.41 feet** across the grantor's tract with a proposed right of way line being 8.00 feet west of and parallel with the westerly right of way line for Cleveland Avenue as measured by right angles to an iron pin set in the south line of Lot 10 of said Simons Neil and Simons Linden Addition, same being the north line of the grantor's tract (*said Lot 711*);

Thence **S 86 degrees 13 minutes 41 seconds E** a distance **8.00 feet** with the south line of said Lot 710 and the north line of the grantor's tract (*said Lot 711*) to an iron pin set in the southeast corner of said Lot 710, said iron pin being also in the northeast corner of the grantor's tract (*said Lot 711*) and lies in the westerly right of way line for Cleveland Avenue;

Thence **S 03 degrees 46 minutes 19 seconds W** a distance of **34.42 feet** with the westerly right of way line of Cleveland Avenue and the east line of the grantor's tract (*said Lot 711*) to the **TRUE POINT OF BEGINNING**, containing 0.006 acre of land more or less.

The above described area contains a total of **0.006 acres** within Franklin County Auditor's Parcel Number 010-060065-00, which includes 0.000 acres in the present road occupied.

Grantor claims title by Instrument recorded in Instrument No. 200805130073694 in the records of Franklin County, Ohio.

Iron pins set, as shown on plan and in the above description are 5/8 inch steel rod, thirty (30) inches long with a cap stamped "Rii".

Bearings used in this description are based on Ohio State Plane Coordinate System, South Zone as per NAD 83 and were established utilizing ODOT's VRS System, GPS equipment and procedures and established bearing of N 03°46'19" E on the centerline of Cleveland Avenue.

This description was prepared from existing records and a field survey performed in August 2014.
