Preparing site for soil excavation activities within wooded setting, excavate potentially contaminated soil in accordance with OSHA and USEPA regulations, coordinate transport and disposal spoil material, backfill excavation to grade.

Work under this contract shall be completed within 55 calendar days after the NTP is issued.

This project will remove and test for hazardous material from the banks of Griggs Reservoir, near the City of Columbus Indian Village Day Camp. Griggs Reservoir is a water supply source for the Dublin Road Water Treatment Plant, one of three City of Columbus drinking water treatment

facilities. Site remediation is part of a Voluntary Action Plan with Ohio EPA. No community outreach was performed for this project. The work is being coordinated with the Ohio EPA.
