Sir,

The following investigation was conducted concerning the City of Columbus' 2021 annual objection to the renewal of liquor permit **91335120649** issued to **UDF Limited Partnership II**, which is doing business as **United Dairy Farmers 649** located at **530 S. Hague Avenue, Columbus, Ohio 43204**.

After reviewing the State of Ohio, Franklin County, and City of Columbus records regarding the above liquor permit establishment, the following information has been compiled to support the objection to the renewal of the aforementioned permit issued by the State of Ohio.

The above listed liquor establishment has been issued **C1 and C2** permits by the Division of Liquor. This permit grants the permit holder the privilege to sell alcoholic beverages at the above listed address.

A review of the Columbus Division of Police records revealed the Division of Police has created **(59) fifty-nine** official police reports concerning incidents at the listed liquor establishment between **January 2020** and **November 2021**. These reports referenced robberies, assaults, menacing, intoxicated persons needing assistance, open container violations, drug offenses, overdoses, prostitution, domestic violence, and motor vehicle theft, including:



In addition, the Columbus Division of Police have been dispatched to **530 S. Hague Avenue, Columbus, Ohio 43204** on **(262) two hundred sixty-two** calls for service, **(131) one hundred thirty-one** in 2020, and **(130) one hundred thirty** in 2021 at **UDF**. These calls for service include responses to a shooting a stabbing, persons with a gun or knife, robberies, narcotics complaints, prostitution, intoxicated persons needing assistance, sexual assault, overdoses, indecent exposure, disturbances (including disturbances with a high risk of violence and disturbances involving intoxicated individuals and open containers), arrest of person with felony warrants, fires, trespassing, assaults, fights, domestic violence, O.V.I.'s, property destruction, and motor vehicle theft.

The Columbus Division of Fire was also dispatched to the location **(54) fifty-four** times from October 2020 through October 2021, including for **(8) eight** overdoses.
