[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, part of Quarter Township 3, Township 1, Range 16, United States Military Lands and being part of a 1.429 acre tract of land in the name of GCR Retail, LLC, an Ohio limited liability company, as described in IN. 201802280027766, all records are on file in the Franklin County Recorder's Office, and being a tract of land lying on the left side of the centerline of Right of Way of State Route 16 (East Broad Street), hereafter referred to as S.R. 16, as shown on the FRA-16-7.79 plans made by the Ohio Department of Transportation, and is more particularly described as follows:

Beginning for Reference at a concrete monument found in the southerly Right of Way line of said S.R. 16 (East Broad Street), being 33.00 feet right of centerline Station 205+00.00 as delineated in the FRA-16-7.79 centerline plat as recorded in Plat Book 29, Page 4;

Thence North 08°08'48" West, perpendicular to and leaving said southerly Right of Way line a distance of 33.00 feet to a point in said centerline, being centerline Station 205+00.00;

Thence South 81°51'12" West, with said FRA-16-7.79 centerline, a distance of 534.94 feet to a point of at centerline Station 199+65.06;

Thence North 08°07'11" West, perpendicular to said centerline, a distance of 118.00 feet to a point in the westerly line of a 1.170 acre tract in the name of Moo Moo East Broad, LLC, an Ohio Limited Liability Company, as described in IN. 200810170154428, being 118.00 feet left of centerline Station 199+65.11 and the **True Place of Beginning** for the tract of land herein being described;

Thence through said 1.429 acre tract, the following six (6) courses:

1. South 81°51'12" West, a distance of 30.12 feet to a point 118.00 feet left of centerline Station 199+35.00;

2. North 08°08'48" West, a distance of 13.00 feet to a point 131.00 feet left of centerline Station 199+35.00;
3. South 81°51'12" West, a distance of 46.00 feet to a point 131.00 feet left of centerline Station 198+89.00;
4. South 08°08'48" East, a distance of 10.00 feet to a point 121.00 feet left of centerline Station 198+89.00;
5. South 81°51'12" West, a distance of 81.00 feet to a point 121.00 feet left of centerline Station 198+08.00;
6. South 82°20'12" West, a distance of 86.56 feet to a point in the easterly line of a CFA Real Property I, LLC, a Georgia limited liability company, as described in IN. 200904240057758, being 121.00 feet left of centerline Station 197+20.42;

Thence North 08°07'11" West, with said easterly line, a distance of 20.00 feet to a point 141.00 feet left of centerline Station 197+20.26;

Thence through said 1.429 acre tract, the following five (5) courses:

1. North 82°20'12" East, a distance of 22.76 feet to a point 141.00 feet left of centerline Station 197+43.02;
2. South 20°11'32" East, a distance of 8.19 feet to a point 133.00 feet left of centerline Station 197+44.80;
3. North 82°20'12" East, a distance of 137.09 feet to a point 132.37 feet left of centerline Station 198+83.01;
4. North 08°08'48" West, a distance of 1.63 feet to a point 134.00 feet left of centerline Station 198+83.01;
5. North 81°51'12" East, a distance of 82.11 feet to a point in said westerly line, being 134.00 feet left of centerline Station 199+65.12;

Thence South 08°07'11" East, with said westerly line, a distance of 16.00 feet to the **True Place of Beginning**.

Bearings for this description are based on Ohio State Plane Coordinates, South Zone, NAD 83 (2007) Datum as established utilizing a GPS survey performed in November 2017, holding North 82°20'12" East for the centerline of East Broad Street (State Route 16).

The stations referred to in this description are from the centerline of Right-of-Way of State Route 16, as found on the FRA-16-7.79 centerline plat as recorded in Franklin County Recorder's Office in Plat Book 29 Page 4.

The stations are shown on the FRA 16 8.24 centerline plat, as recorded in Franklin County Recorder's Office in Plat Book 132 Page 106-109.
