[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, Township of Plain, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.026 acres within a 1.956 acre parcel conveyed to SARA Z RASTEGAR, as described in Official Record 30996 E11 (see Instrument Number 200810030148794) and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning at an iron pin set on the easterly proposed right-of-way of Hamilton Road, said point being 60.00 feet right of centerline Station 106+29.21;

Thence along the said easterly existing right-of-way of Hamilton Road, North 3°19'21" East, a distance of 141.01 feet to an iron pin set on the northerly property line of the said 1.956 acre tract and being 60.00 feet right of centerline Station 107+70.22;

Thence along the northerly line of the said 1.956 acre tract, South 86°54'39" East a distance of 9.00 feet to a point being 69.00 feet right of centerline Station 107+70.25;

Thence across the said 1.956 acre tract, South 3°19'21" West a distance of 54.27 feet to a point being 69.00 feet right of centerline Station 107+16.00;

Thence across the said 1.956 acre tract, South 5°18'11" West a distance of 86.81 feet to the southerly line of the said 1.956 acre tract and being 66.00 feet right of centerline Station 106+29.24;

Thence along the said southerly line, North 86°54'39" West a distance of 6.00 feet to the point of beginning, containing 0.026 acres, more or less.

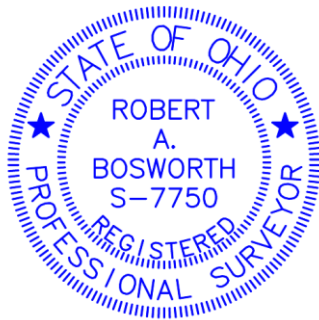

This description is based upon a field survey performed by Dynotec, Inc. in January, 2015.

Grantor claims title by Official Record 30996 E11 (see Instrument Number 200810030148794) in the Franklin County Recorder's Office.

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (96 CORS) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Hamilton Road as North 3°19'21" East.

The stations referred to herein are from centerline right-of-way of Hamilton Road as found on O.D.O.T. right-of-way plan Hamilton Road.
