[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, being located in Quarter Township 3, Township 2, Range 16 of the United States Military Lands and being 0.010 acres within a 3.833 acre parcel conveyed to KEITH A HOOGLAND, TRUSTEE UNDER TRUST AGREEMENT DATED JULY 12, 2006 AND OF THE TRUST KNOWN AS THE HOOGLAND 2006 GRANTOR TRUST, as described in Instrument Number 201101110006191 and being more particularly described as follows:

Being a parcel of land lying on the right side of the centerline of a survey made for project Hamilton Road, made by the Department of Transportation, and being located within the following described points in the boundary thereof:

Beginning on the easterly existing right-of-way of Hamilton Road, said point being 60.00 feet right of centerline Station 100+25.37;

Thence along the said easterly existing right-of-way of Hamilton Road, North 3°19'21" East, a distance of 32.08 feet to the northwesterly corner of the said 3.833 acre tract and being 60.00 feet right of centerline Station 100+57.45;

Thence along the northerly line of the said 3.833 acre tract, South 86°56'37" East a distance of 13.00 feet to a point being 73.00 feet right of centerline Station 100+57.51;

Thence across the said 3.833 acre tract, South 3°19'21" West a distance of 32.08 feet to a point on the southerly line of the said 3.833 acre tract and being 73.00 feet right of centerline Station 100+25.43;

Thence along the said southerly line, North 86°56'04" West a distance of 13.00 feet to the point of beginning, containing 0.010 acres, more or less.

The above described area is within Auditors Permanent Parcel Number 010-226263.

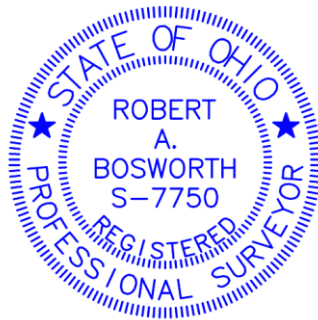
This description was prepared and reviewed on May 4, 2016 by Robert A. Bosworth, Registered Surveyor #7750.

Grantor claims title by Instrument Number 201101110006191 in the Franklin County Recorder's Office.

The basis of bearings shown are based on the State Plane Coordinate System, Ohio South, as per NAD 83 (96 CORS) established by Dynotec, Inc. using GPS procedures and equipment, which sets the centerline of Hamilton Road as North 3°19'21" East.

The stations referred to herein are from centerline right-of-way of Hamilton Road as found on O.D.O.T. right-of-way plan Hamilton Road.
