BID RECOMMENDATION-ELEVEN FOOT DUMP BODY WITH

ATTACHMENTS-BID PROPOSAL #SA003300

The Purchasing Office opened formal bids on July 9, 2009 for the purchase of an Eleven Foot Dump Body with Attachments for the Division of Power and Water. Four (4) bids were received.

America's Body Company was the apparent low bid of \$27,190.00. They, however, did not meet specifications. Items that we took exception with:

- 3.3.2 REQUESTED: 11 foot long x 87/96" wide x 40" front x 12" sides x 20 tailgate. THEIRS: 11 foot long x 84" wide x 40" front x 12" sides x 20" tailgate.
- 3.3.9 REQUESTED: Heavy duty 10 gauge 304 stainless steel **double** walled, double acting tailgate with boxed type vertical and horizontal bracing, spreader chains, quick drop feature with one lever control, overshot type hardware built into the rear corner posts of the dump body, **grease zerks** on the pins and linkage at the left front corner of the dump body to release the lower pins of the tailgate.

THEIRS: Heavy duty 10 gauge 304 stainless steel **single** walled, double acting tailgate with boxed type vertical and horizontal bracing, spreader chains, quick drop feature with one lever control, overshot type hardware built into the rear corner posts of the dump body, **no grease zerks** on the pins and linkage at the left front corner of the dump body to release the lower pins of the tailgate.

- 3.4.8 REQUESTED: **32,000**# lifting capacity THEIRS: **20,600**# lifting capacity

The second lowest bid was Ace Truck Body, at \$27,671.00, and they meet our specifications.
