First United Methodist Church, New Philadelphia, Ohio

Project manager / architect / designer

Master plan, renovation and addition to an existing church in downtown New Philadelphia, Ohio. The new 1.8 million, 14,000 sq.ft. facility adds a contemporary worship space, administration space, restrooms, kitchen, and new building entrance. The addition represents the church's mission to reach out to families and the public by offering a facility that can host a variety of events: 2007-2010

Ohio State Highway Patrol – Post 23, Lancaster, Ohio

A new \$1.5 million, 6,000 sq.ft. OSHP patrol post. The project is a stand-alone facility that will replace the current facility. Designed as a regional location, the building has a service garage, lockers and storage areas for the patrolmen, an operations center, conferencing, and office space: 2008-2010
