Thence with said southerly right-of-way line, the northerly line of said 0.235 acre tract, with a curve to the left, having a central angle of 00° 50' 25", a radius of 322.30 feet, an arc length of 4.73 feet and a chord bearing and distance of North 73° 41' 13" East, 4.73 feet to a 3/4 inch iron pipe with a "HOCKADEN" cap found at a point of tangency;

Thence North 73° 16' 00" East, continuing with said southerly right-of-way line, the northerly line of said 0.235 acre tract, a distance of 44.98 feet to a point of curvature;

Thence continuing with said southerly right-of-way line, the northerly line of said 0.235 acre tract, with said curve to the right, having a central angle of 25° 27' 54", a radius of 20.00 feet, an arc length of 8.89 feet and a chord bearing and distance of North 85° 59' 57" East, 8.82 feet to a point at the TRUE POINT OF BEGINNING;

Thence continuing with said southerly right-of-way line and the westerly right-of-way line of Olentangy River Road, of record in Plat Book 33, Page 52, with the northerly and easterly line of said 0.235 acre tract, with said curve to the right, having a central angle of 64° 32' 06", a radius of 20.00 feet, an arc length of 22.53 feet and a chord bearing and distance of South 49° 00' 03" East, 21.35 feet to a 3/4 inch iron pipe with a "HOCKADEN" cap found;

Thence South 16° 44' 00" East, with said westerly right-of-way line, the easterly line of said 0.235 acre tract, a distance of 2.17 feet to a point;

Thence South 73° 16' 00" West, across said 0.235 acre tract, a distance of 11.40 feet to a point;

Thence North 16° 44' 00" West, continuing across said 0.235 acre tract, a distance of 20.23 feet to the TRUE POINT OF BEGINNING, containing 0.004 acre, more or less.

The bearings shown hereon are based on the Ohio State Plane Coordinate System, South Zone, NAD 83 (1986). Said bearings originated from a field traverse which was tied (referenced) to said coordinate system by GPS observations of Franklin County Engineering Department monuments COC4-83, and RINGLE. The portion of the centerline of Olentangy River Road, having a bearing of North 16° 44' 00" West, is designated the "basis of bearing" for this survey.
