Street Lighting Improvements for Agler Road consists of the installation of street lighting in the area of South of Agler Road, between Clubhouse Drive and Brentnell Avenue. This installation will consist of the installation of overhead wood street lighting poles with 120 volt LED luminaires. Additions to the existing lighting on Agler Road will also be required using overhead wood poles and High Pressure Sodium (HPS) luminaires.
