PERPETUAL EASEMENT TO CONSTRUCT AND MAINTAIN A SEWER

A perpetual easement for the construction and maintenance of a sewer in, upon and over the within described real estate. Grantor/Owner herein retains the right to use said real estate for any and all other purposes provided that such use does not interfere with nor impair the exercise of the easement herein granted (as used herein, the expression "Grantor/Owner" includes the plural, and words in the masculine include the feminine or neuter).

[Surveyor's description of the premises follows]

Situated in the State of Ohio, County of Franklin, City of Columbus, Section 26, ½ Section 39, Township 5, Range 22, Refugee Lands, being an area of land located within that 0.842-acre tract (Parcel Three) as described in a deed to SHC Lockbourne Rd LLC, of record in Instrument No. 201008180106216, Recorder's Office, Franklin County, Ohio, said area being on the RIGHT side of Lockbourne Road (and north of S.R. 104) as delineated upon plans prepared for the City of Columbus and designated as 2746 DR. E, and being more particularly described as follows:

All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning at the intersection of the southerly line of said 0.842-acre tract and the easterly right-of-way line of Lockbourne Road located 30.00 feet RIGHT of station 80+70.48;

Thence North 03°54'25" East, along said right-of-way line, a distance of 11.00 feet to a point located 30.00 feet RIGHT of station 80+81.48;

Thence South 85°26'25" East, a distance of 9.00 feet to a point located 39.00 feet RIGHT of station 80+81.38;

South 03°54'25" West, parallel to said right-of-way line, a distance of 11.00 feet to a point in the southerly line of said 2.6755-acre tract located 39.00 feet RIGHT of station 80+70.38;

Thence North $85^{\circ}26'25''$ West, along said southerly line, a distance of 9.00 feet to the place of beginning.

Containing 0.0023 acre of land, of which the present road occupies 0.0000 acre leaving a net take of 0.0023 acre.

Bearings herein are based on field observations of established control points from the Franklin County Engineers Office, resulting in a bearing of North $03^{\circ}54'25''$ East, for the existing centerline of Lockbourne Road north of Marion Road.
