Merion recorded in Plat Book 17, page 256 conveyed to Barbara A. Graham by deed recorded in Instrument No. 199905060115016 (all references to deeds, microfiche, plats, surveys, etc. refer to the records of the Franklin County Recorder's Office, unless noted otherwise) and being more particularly bounded and described as follows:

BEGINNING at the northeast corner of said 0.082 acre tract, said point being the intersection of the south right of way line of an alley (16' public right of way) between Jenkins Avenue (50' public right of way) and Southwood Avenue (40' public right of way) with the west right of way line of 17th Street (50' public right of way), 25.00 feet left of centerline Station 101+32.14;

thence along the east line of said 0.082 acre tract and the west right of way line of said 17th Street, South three degrees thirty-two minutes forty-four seconds West (S03°32'44"W), for thirteen and 49/100 feet (13.49') to a point 25.00 feet left of centerline Station 101+18.65;
