Speert in Instrument 200605120091836 and being on the westerly existing right of way of relocated Watt Road as acquired by the State of Ohio in Deed Book 2919, Page 89 and being the grantor's northeast corner, said pin being 75.74 feet right of the centerline of Watt Road at station 22+44.01; Thence, on a line of South 16 degrees 27 minutes 07 seconds West 430.63 feet to a 5/8 inch rebar found in good condition on the westerly existing right of way as acquired in Official Record 29304, page I17 to the City of Columbus, said pin being the northeast corner of said 13.871 acre tract and the southeast corner of a 4.691 acre tract conveyed to Kristee M. Rogers and Julie A. Moudry, Co-Trustees of the Kristee M. Rogers and Julie A. Moudry Revocable Family Trust in Instrument 202312050126377, said pin being 50.00 feet left of the centerline of said Sunbury Road at station 19+01.96 and being the **TRUE POINT OF BEGINNING** for the parcel herein described:
