Work under this contract shall be completed within 90 calendar days after the date of the Notice to Proceed.

This project will facilitate the upgrades to existing lighting system with the installation of energy efficient lighting systems at the Griggs Reservoir, Bellpoint maintenance and Hoover Reservoir facilities. The project will replace T12 lamps and fixtures with more efficient T8 lamps and fixtures. Also, the project will replace Metal Halide, High Pressure Sodium and Quartz flood lights with Light Emitting Diodes (LED) lamps for an approximate 30% reduction in energy consumption. In addition, the City will apply for rebates with AEP and First Energy as an added incentive for this project.
