This project provides for general rehab of the area distribution system and includes construction of new water lines, abandoning existing 2-inch diameter and smaller water lines, installing fire hydrants, and transferring water services. The purpose of the project is to improve flow and water quality, improve fire protection, and replace water mains that require repeated regular maintenance. This project will include the installation of approximately 4,800 feet of 6-inch water lines at the following locations: Whittier Street, Ebner Street, City Park Avenue, Washington Avenue, Kent Street and Gault Street.

6. **A narrative timeline for the contract including a beginning date, beginning and ending dates for known phases of the contract and a projected ending date.**

The Notice to Proceed (NTP) date is estimated to be May 9, 2011. The work under this contract shall be completed within 180 calendar days after NTP is issued. Construction completion date is estimated to be November 5, 2011.
