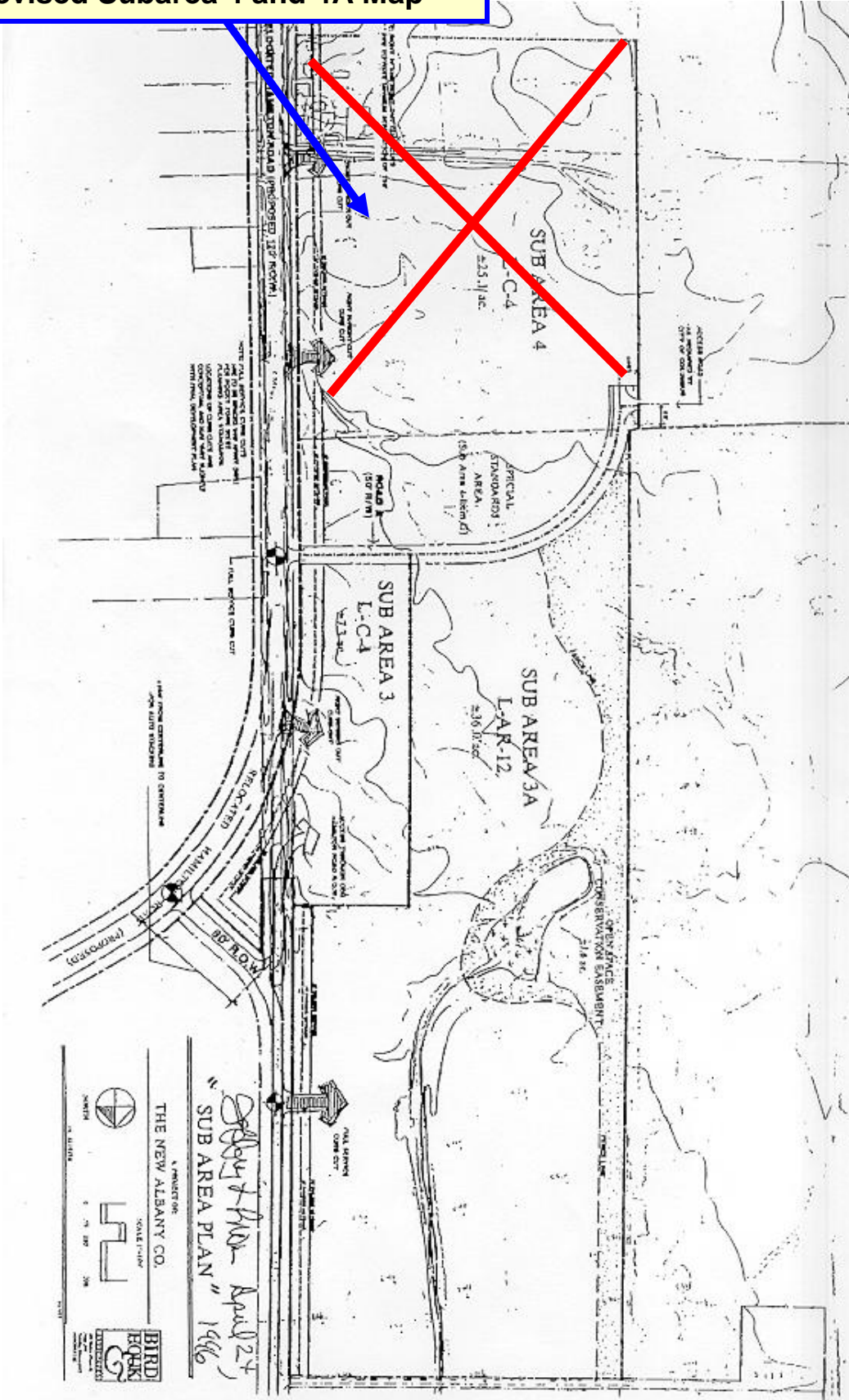
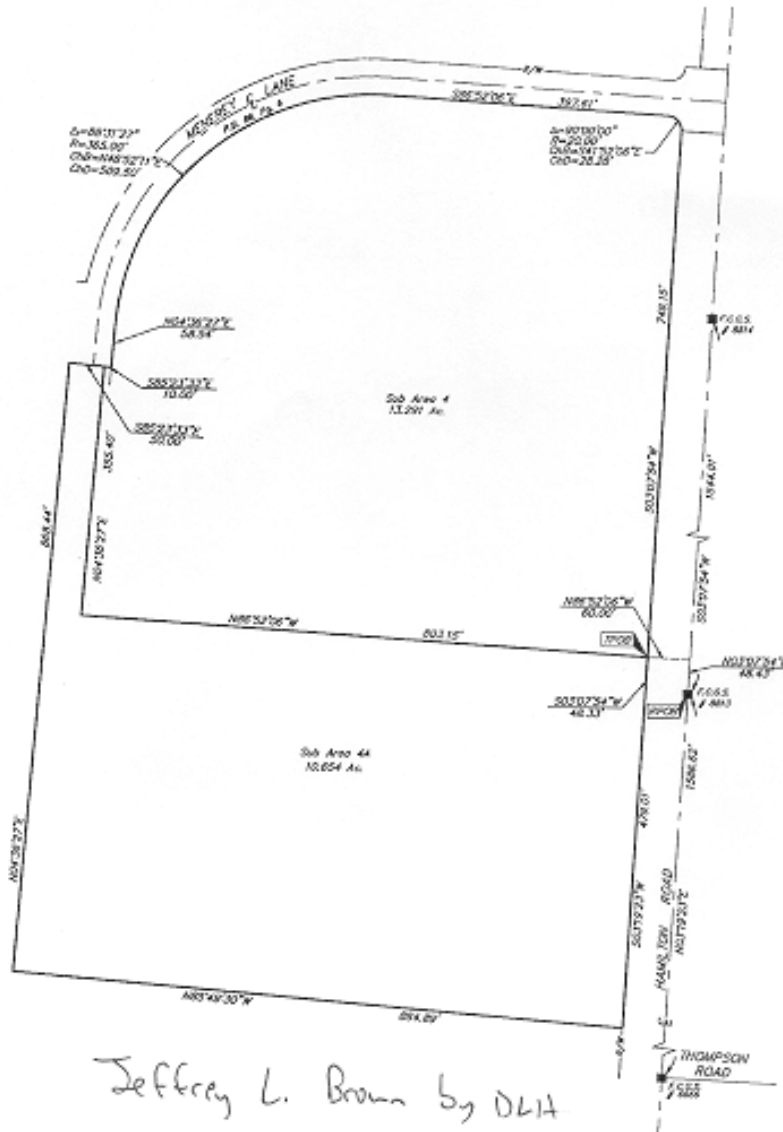


See "Zoning Exhibit" (Pg. 2) for revised Subarea 4 and 4A Map
