Situated in the State of Ohio, County of Franklin, City of Columbus, Section 26, ½ Section 39, Township 5, Range 22, Refugee Lands, being a strip of land located within that 24.588-acre tract (Exhibit "A") as described in a deed to Refugee Industrial Park Partners, LLC. of record in Instrument No. 200401060004341, all references being to the records of the Recorder's Office, Franklin County, Ohio, said strip being on the RIGHT side of Lockbourne Road (and north of S.R. 104) as delineated upon plans prepared for the City of Columbus and designated as 2746 DR. E, and being more particularly described as follows:

All references herein to station and offset are to the centerline of construction of Lockbourne Road.

Beginning at the intersection of the southerly line of said 24.588-acre tract with the proposed easterly right-of-way line of Lockbourne Road, said point being located 35.00 feet RIGHT of station 32+69.92;

Thence North 03°45'55" East, along the easterly line of proposed Parcel 10-WD (5.00 feet east of and parallel to the existing right-of-way line), a distance of 667.79 feet to a point in the northerly line of said 24.588-acre tract located 35.00 feet RIGHT of station 39+37.71;

Thence South 86°13'35" East, along said northerly line, a distance of 7.00 feet to a point located 42.00 feet RIGHT of station 39+37.71:

Thence South 03°45'55" West, through said 24.588-acre tract, a distance of 667.78 feet to a point in the southerly line of same located 42.00 feet RIGHT of station 32+69.93;
